Admission without an LSAT Score



UofSC students are invited to apply to law school via the new **USC Now 2 JD** pipeline program.

The time and cost involved in preparation for the LSAT is a common barrier for students seeking admission into a JD program.

The **USC Now 2 JD** pipeline program enables qualified candidates to apply for admission without an LSAT score.

WHO IS ELIGIBLE TO APPLY?

- Candidates must have earned, or will earn, a bachelor's degree from a campus of the University of South Carolina.
- Candidates must have a cumulative undergraduate grade point average of 3.60 or higher as reported and calculated by the Law School Admission Council's Credential Assembly Service.

NO LSAT REQUIRED:

Candidates can seek admission with

- the **SAT or ACT** at or above the 85th percentile nationally (at the time the test was taken)

Candidates with valid LSAT scores cannot participate in this pipeline program but are welcome to submit an application prior to March 1st.

WHAT IS THE APPLICATION PROCESS?

APPLICATION:

- Eligible applicants will begin by creating an account at www.lsac.org.
- Once an account has been created, candidates can submit an application to the UofSC School of Law.

APPLICATION DETAILS

APPLICANTS:

- Eligible candidates will be considered on a rolling basis.
- It is the responsibility of the candidate to confirm through the Law Admissions Office that the program is still open before they apply.
- An admissions decision will be provided within two weeks of the date that the application is complete in the Law Admissions Office.
- Candidates must notify the Admissions Office of the name of the alternative test (ACT or SAT) and the month and year of all valid tests.
- Candidates must comply with requirements for documentation of test scores and percentiles for each valid test administration.
- Visit www.law.sc.edu for more details regarding eligibility and program requirements.

WHAT HAPPENS AFTER ADMISSION?

ADMITTED CANDIDATES:

- Must confirm they will not register for a future administration of the LSAT.
- Are eligible to be considered for merit scholarship assistance.
- Will be notified of the deadline to accept or decline the offer of admission and any scholarship offer made to them.
- Will be required to confirm their intent to enroll as outlined in the offer of admission.
- Must agree to comply with pre-enrollment requirements of the law school.
